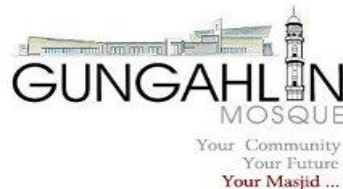

7. This agreement will endure to the benefit of and be binding upon the respective heirs, executors, administrators, successors and assigns of the borrower and the lender.
8. This Agreement may only be amended or modified or rescinded in writing by the mutual agreement of the Parties.

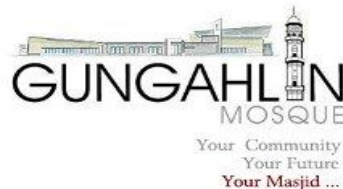
